Dear Chairman Goodlatte, Ranking Member Conyers, Chairman Marino and Ranking Member Cicilline;

The members of the Marketplace Fairness Coalition, a diverse group of like-minded organizations representing millions of American employers, are disappointed in the lack of action on the most pressing interstate commerce issue for America's Main Street merchants - remote sales tax parity - in today's legislative hearing on H.R. 2887, the No Regulation Without Representation Act.

For more than 4 years our coalition has worked extensively with the House Judiciary Committee to find a legislative solution to level the playing field for all merchants with simplification and protections for remote sellers that reflect the realities of today's dynamic multichannel marketplace. The deficiencies in our current system of remote sales and use tax collection are a growing problem in need of Congressional resolution.

Instead of moving forward with bipartisan legislation such as H.R 2193, the Remote Transactions Parity Act, the committee is considering dangerous and overreaching legislation that codifies the outdated physical nexus model, negates significant consumer protections and undermines states' rights.

We have continually encouraged the committee to exercise its constitutionally granted interstate commerce authority, but believe that good policy would dictate that this responsibility should be undertaken on a direct and specific case-by-case basis. Unfortunately, under Chairman Goodlatte's leadership the committee has been unable to fulfill that role.

As you know, the Supreme Court has addressed this failure and invited further litigation. Specifically, in his concurring opinion in *Brohl v DMA*, Justice Kennedy stated, "Given changes in technology and consumer sophistication, it is unwise to delay any longer a reconsideration of the Court's holding in *Quill*. A case questionable even when decided, *Quill* now harms States to a degree far greater than could have been anticipated earlier.... The legal system should find an appropriate case for this Court to reexamine *Quill* and *Bellas Hess*."

In the absence of Congressional action, states are pursuing litigation to overturn the <u>Quill</u> decision. The outcome of this litigation will certainly alter the dynamic that currently provides an opportunity for a balanced legislative solution to the remote sales tax problem.

The Marketplace Fairness Coalition remains committed to working with Congress to take advantage of the unique and timely opportunity to address various issues related to state taxation and nexus this year under the shared collective objective to: 1) provide a simple, efficient and logical process to remove disparity at the point of purchase; 2) protect businesses from regulatory overreach; and 3) meet the critical needs of the communities which we serve.

It is our hope that regular order can proceed to move legislation based on destination-based remote sales tax parity combined with robust small business protections and regulatory simplifications to curtail state regulatory overreach on the collection of remote sales and use taxes. We look forward to having the opportunity to continue to work with you, the Committee and other interested Members of Congress to reach consensus on a workable remote tax collection resolution and enact it this year.
