

Percent who have participated in this activity in the past 12 months








MOST PERSONAL/SOCIETAL CONCERNS RECEDE SLIGHTLY








SLIGHTLY FEWER EXPECT MORE STRESS A MONTH FROM NOW

GROWING % KNOW SOMEONE WHO SUFFERED BUT DIDN'T DIE


Do you know anyone personally who suffered seriously from COVID-19 but did not die?






DESPITE THAT, 41% STRONGLY AGREE: VIRUS LESS SCARY NOW

IT'S TIME TO RETURN TO NORMAL

- Despite recognizing that COVID cases are rising where they live and nationwide, most have little to no concern about contracting the virus
- They believe it's time to return to a sense of normalcy
 - They know a lot more than they did nine months ago how the virus is transmitted and what they need to do to stay healthy
 - People they know have contracted it and recovered they believe they are healthy and would recover, too
 - Some question the media's reporting, saying they "sensationalize" a lot of things to get clicks and to get people to tune in – what does it mean to die from "complications due to COVID?"
- With the vaccine rollout, almost all expect to be back to normal as a country between mid-2021 and early 2022, but local and state governments' restrictions will play a large role, too



THEY'RE DIVIDED OVER WHETHER TO GET VACCINATED

- Those planning to get the vaccine are satisfied with the rollout plan, which will allow the most vulnerable to get it first
- They expect to receive theirs by 2Q of 2021, and they're OK with that
- They have heard it's 90%+ effective and believe the benefits will outweigh the risks, including:
 - Moving us toward a return to normal
 - Improvements in the economy and people's state of mind
- Interestingly, they have little appetite for convincing those not planning to get it to change their mind they believe it's their body, their choice



THEY'RE DIVIDED OVER WHETHER TO GET VACCINATED

- Those planning to not get vaccinated have concerns:
 - We don't know enough about the repercussions from it, including side effects we need more data
 - Some have taken the flu vaccine and still contracted it
 - One respondent cited a vaccine given in the Philippines that killed a lot of children
- Again, some people believe getting the vaccine isn't necessary because they would recover from COVID if infected



MAJORITY EXPECT VACCINE BY END OF FEBRUARY


When do you anticipate that a COVID-19 vaccine will be widely available in this country?


BUSINESS SHOULD BE ABLE TO BAN THE NON-VACCINATED












Which of the following conditions is closest to your current point of view... Tour a home listed for sale (outside of an open house)





STRONG WORRY ABOUT STATE AND LOCAL BUDGETS


I am concerned about the financial burden that COVID-19 is placing on state and local budgets where I live.





2/3 WORRY ABOUT HIGHER TAXES


I am concerned that state and local taxes might have to be raised in order to pay for the expanded COVID-19-related services my state and locality are providing.






HALF HAVE NOTICED SURCHARGE; ¼ THINK IT'S FROM GOV'T

Have you personally noticed that certain businesses, such as restaurants, are adding a COVID-19 surcharge to the bill?




[Among those who noticed] Is this surcharge imposed by the business on its own, or is it imposed by the government like a sales tax?





HIGHER PERCENTAGE THINK THE # OF CASES WILL RISE


When it comes to the number of new daily COVID-19 cases in the U.S. over the next two months, do you expect the number to...


How eager are you to return full time to your workplace outside of your home, relative to three months ago?


