How Does S. 1955 Differ From HR 525 & S. 406

- Fully insured SBHPs
- Regulated by state insurance commissioner
- Required coverages included
- State individual and large group rating and underwriting rules preserved
- Tougher sponsor requirements
- Level playing field

Senate Floor Actions

Offered on Tuesday, May 9th Vote to begin consideration approved 96-2 Followed by 30 hours of discussion Vote to avoid filibuster on Thursday, May 11th fails 55-43
