# NAR Sustainability Policy Resources (Feb. 14, 2020)

As requested, below is a compilation of NAR public policy positions, PAG reports, economic research and member resources related to extreme weather events, disaster resiliency/recovery, and sustainability.

### **Current NAR Policy:**

- Pre-disaster preparedness, prevention and proactive risk reduction should be emphasized but post-disaster emergency assistance included
- Private insurance market should be promoted to assume more risk
- Premiums should align with property specific risk and avoid major surcharges or cross subsidies
- Higher building codes and ordinances should be encouraged to avoid costly property damage or retrofits
- Pre-disaster mitigation assistance should be provided to current homeowners
- Full transparency, disclosure and mapping is required for better informed risk decisions
